WHEREAS, Lois W. Campbell SEND GREETING:  
I, the said Lois W. Campbell

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

near the Lawrence Road and designated as part of Lots nos. 73 and 74 of the sub-division of Eastover as shown by Plat record in Plat Book "F", page 42, and having the following metes and bounds, to-wit:
