at and before the signing of these Presents the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant bargain, sell and release unto the said, Alex Burton, his Heirs and Assigns,

All that certain piece, parcel or lot of land situate lying and being in the State and County aforesaid about two miles North of the Greenville County Court House and located to the Say Doug "G" on Monaghan Avenue and being designated as Lot # 23 according to a plat thereof recorded in Office of R. M. C. for Greenville County in Plat Book "A" page 175 and having the following Bmetes and bounds to wit;

Beginning at a pin on the east side of Monaghan Avenue point corners, back lot # 24 and running thence with line of lot # 24 S. 76 E. 206 feet to a pin, thence S. 14 W. 66 feet to a pin joint corners with lot # 22, thence with line of lot # 22 N. 76 W. 206 feet to a pin on Monaghan Avenue; thence with said Avenue N. 14 E. 66 feet to the beginning corner.
