in hand well and truly paid by the said PIEDMONT SAVINGS AND TRUST COMPANY, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents, do grant, bargain, sell, and release unto the said PIEDMONT SAVINGS AND TRUST COMPANY, all that tract or parcel of land, situated in County of Greenville, State of South Carolina, and described as follows:

all that certain lot of land situate near the city of Greenville, in County and State aforesaid, on the east side of the Augusta Road, and known as lot no. 3 of Block "A" of the subdivision known as "Kanatenah" on the plat recorded in Plat Book F, pages 131-133, R.M.C. office for Greenville County, which lot is more particularly described as follows: Beginning at a stake 126.4 feet from the Southeastern intersection of Augusta Road and Oregon Street, and running thence N. 63.35 E. 202.6 feet to stake on line of lot no 4; thence S. 25.51 E. 55 feet to a stake, joint corner of lots 3 and 4; thence S. 63.35 W. 171.4 feet to a pipe on Augusta Road; thence with Augusta Road N. 65.04 W. 63.2 feet to the point of beginning; being the same lot of land conveyed to me by Gideon Timberlake by deed dated October 9, 1935 and recorded in Deed Book 105, page 472, R.M.C. office for Greenville County.
