do hereby bind myself, my Heirs, Executors and Administrators, to warrant and forever defend, all and singular the said premises unto the said Julia D. Charles Attorney, her Heirs and Assigns, from and against me and my

Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same, or any part thereof. And the said Mortgagor... agree... to insure the house and buildings on said lot in a sum not less than Eight Hundred fifty & no/100 Dollars (in a company or companies satisfactory to the mortgagee...), and keep the same insured from loss or damage by fire, and assign the policy of insurance to said mortgagee..., and that in the event that the mortgagor... shall at any time fail to do so, then the said mortgagee... may cause the same to be insured in H. J. Martin's name and reimburse
