WHEREAS, I, the said Sealany Easy
in and by my certain promissory note, in writing, of
even date with these presents, am well and truly indebted to

in the full and just sum of one thousand (\$1,000.00)
Dollars, to be paid one after date

with interest thereon, from date at the rate of eight per cent. per annum to be
computed and paid semi-annually

until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may

sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent of amount due besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part

nos 3, 4, 5, 6, 7, 8 and 9 of a negro section known
as Butler Row, represented by a plat made for
C. C. Hood by H. M. East, July 1928 which plat
is recorded in R. M. C. office for said
Greenville County in Plat Book 44 page 124.

This mortgage is junior in rank to the
mortgage held by the Carolina Loan and Trust

J. E. Medlin by two separate deeds, one dated

329 and one dated April 8, 1929, recorded in
