computed and paid annually

until paid ~~in full~~ all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bar-

gain, sell and release unto the said

Dr. A. White, his heirs and assigns forever, the

following described real estates:

All that certain lot of land situated, lying
and being in the State of South Carolina County
of Greenville, on the West Side of Queen Street in
the Town of West Greenville, and being described
as follows, to-wit: Beginning at an iron pin
on said street, running thence S. 44.00 W. 33.5
feet to an iron pin, corner of Davis line; thence
N. 65.50 W. 152.1 feet to an iron pin on an alley
thence with said alley N. 21.15 E. 45.8 feet
to an iron pin; thence S. 69.00 E. 99 feet to
an iron pin; thence S 51.10 E. 68 feet to the
point of beginning.

Also: All that other lot of land in the County
and State aforesaid on Bob Street in the Town
of West Greenville, and being bounded by lands
of N. Endel and others, and being described
as follows: Beginning at a point on Endel's
property, running thence with Bob Street 54 feet
10 inches to Mr. Cracken's corner, thence with Mr.
Cracken's line 107 feet to an iron pin; thence in
line parallel with Bob Street 54 feet 10 inches
to a point in Endel's line; thence with Endel's
line 107 feet to the beginning.

Also: All that other lot of land in the County
and State aforesaid on Bob Street
in the Town of West Greenville, having a frontage
of 46 feet on West side of said Bob Street and
running back in parallel lines along line
of Mollie Simpson a depth of 160 1/2 feet, more or
less.
