Office for Greenville County, S.C. which Plat is hereby referred to as a part of this description. This is the same lot described and conveyed to me by deed recorded in Book 91 at Page 156.

also all of my right, title, and interest of, in and to all that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, and County of Greenville, in what is known as "City View" being known and designated, as Lot no. Six according to a plat of the Property of W. P. Coopers and R. L. Simmons, dated January 1913, made by F. S. Rogers, Engineer and recorded in Plat Book "D" at Page 79, said lot of land being described by meters and bounds as follows; to-wit: Beginning at an iron pin on O'neall Avenue One hundred Fifty feet from the intersection of O'neall Avenue and Parker Avenue, and running thence N. 81-45 W. One hundred Sixty eight feet to an iron pin; thence S. 81-30 W. Forty-five feet to an iron pin; thence S. 10-E. One Hundred Sixty-eight feet to an iron pin on O'neall Avenue; thence with O'neall Avenue N. 81-30 E. Fifty feet to the point of beginning. Said Lot is the same conveyed to J. C. Hambright by Simmons Realty Company June 9, 1919, deed recorded in R. M. C. Office for said County in Book 72, Page 321.
