 computed and paid semi-annually

until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of Five percent of amount due

All that piece, parcel or lot of land in Greenville Township, County and State aforesaid, in the City of Greenville, having the following metes and bounds, to-wit:

Beginning at a point at the corner of Davis Street and McBee Avenue, and running thence with McBee Avenue 48.25 feet to a point at the corner of Lot of Good Samaritan Lodge, thence with line of lot of the said Lodge 60 feet to an iron pin, thence in a northerly direction 20 feet, thence in a westerly direction 18.4 feet, thence in a southerly direction with line of Lizzie White 70.3 feet to a point on Davis Street, thence with Davis Street 82 feet to the beginning corner and being the same lot conveyed to Mrs. A.
