MORTGAGE OF REAL ESTATE

I, Virginia B. Mc David

TO ALL WHOM THESE PRESENTS MAY CONCERN:

SEND GREETING:

WHEREAS, I, the said Virginia B. Mc David  
 in and by a certain promissory note in writing, of  
 even date with these presents, am well and truly indebted to  
 C. W. Mc David  
 in the full and just sum of Twenty-five hundred and 00/100 dollars  
 Dollars, to be paid One year after date 1/2

with interest thereon, from date January 1st  
 computed and paid annually at the rate of 8 per cent. per annum to be  
 until paid in full all interest not paid when due to be interest at the same rate as principal; and if any portion of principal  
 or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
 sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10/100  
 besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
 thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being  
 thereto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said Virginia B. Mc David,  
 in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said  
 C. W. Mc David,  
 according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said

Virginia B. Mc David  
 in hand well and truly paid by the said C. W. Mc David  
 at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released and by these Presents do grant, bar-  
 gain, sell and release unto the said C. W. Mc David.  
 all that tract of land situate, lying and being in the  
 State and County aforesaid, and in Fairview township  
 containing forty and 1/100 (40.1) acres more or less, and being more  
 particularly described as follows: Beginning at a P. O. on Georgia  
 road and running thence N. 53 3/4 W. 24. 22 to stone 34; thence  
 S. 69 W. 17 20 to stone 34; thence S. 24 3/4 E. 23. 75 to stone 34; thence  
 N. 51 1/2 E. 3. 58 to stone; thence N. 24 3/4 W. 17. 00 to stone 34; thence  
 S. 79 E. 30. 00 to stone 34 by peach tree on Georgia road; thence  
 along said road N. 20 E. 4. 28 to the beginning corner and being  
 the same land conveyed to V. F. Kirk by Robert Sullivan by  
 deed dated the second day of January 1920, and on the 24th day  
 of March 1924 deeded to C. W. Mc David by C. Inman, Master, under  
 foreclosure proceedings.
