 in and by my certain Note or obligation bearing even date herewith, stand indebted unto THE PRUDENTIAL INSURANCE COMPANY OF AMERICA (a corporation duly chartered under the laws of the State of New Jersey and duly licensed to do business within the State of South Carolina, by the laws of said State) in the full and just principal sum of Forty five hundred and no/100 Dollars (\$ 4,500.00), with interest thereon from the date hereof, at the rate of set forth in said note per cent. per annum, said principal sum being payable in instalments of Twenty-two and 50/100 Dollars each on the first day of each and every month hereafter, the last instalment (being the balance of principal remaining due) being payable on the 1st day of May 1955, and said interest being payable monthly on the same days as the instalments of principal, as reference being had to said Note will more fully appear; default in the payment of any instalment of principal or interest to render the whole debt due at the option of the Mortgagee.

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being on the northwest side of West Jarvis Road, near the City of Greenville, in the County of Greenville, State of South Carolina, known and designated as Lots nos. 5 and 6 on plat of property of J. B. League, made by Dalton & Neres, Engineers, May 1931, and having, according to said plat and a recent survey made by R. E. Dalton, September 16, 1938, the following metes and bounds to-wit:-

Beginning at an iron pin on the northwest side of West Jarvis Road, said pin being 126 feet in a southwesterly direction from the northwest corner of the intersection of West Jarvis Road and Aberdeen Drive and running thence with the northwest side of West Jarvis Road S. 69° 50' N. 296.8 feet to an iron pin corner of Lot No. 4; thence with the line of Lot No. 4 N. 20° 45' N. 200 feet to an iron pin; thence N. 69° 50' E. 65.5 feet to an iron pin; thence S. 69° 38' E. 307 feet to an iron pin on the northwest side of West Jarvis Road, the beginning corner.
