even date with these presents, am well and truly indebted to R. L. Ford.

in the full and just sum of Five hundred twenty-five and no/100 dollars  
Dollars, to be paid August 1st 1920

with interest thereon, from date at the rate of 8 per cent per annum to be  
computed and paid Annually

until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing of an attorney's fee of ten per cent

besides all costs and expenses of collection, to be  
added to the amount due on said note. To be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note reference being  
thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, Annie A. Mc Intyre  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to  
Annie A. Mc Intyre  
in hand well and truly paid by the said R. L. Ford

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bar-  
gain, sell and release unto the said R. L. Ford.

All that certain piece, parcel and lot of land situate, lying  
and being in the State and County aforesaid, Chiche Springs  
township, near the town of Greer, on the South side of the  
National Highway bounded on the East, South and West by  
lands of R. L. Ford, on the north by the National Highway and  
being the same lot of land conveyed to me this day by deed  
from R. L. Ford, and having the following courses and  
distances: Beginning on an iron pin on the South side of the  
National Highway Corner of lot number three as shown on  
Plat of the R. L. Ford property said plat prepared by  
W. A. Christopher, Surveyor, March 2nd, 1923, and runs thence  
with the said highway S. 76-10 E. 40 fut to a bend; thence  
S. 73-30 E. 40 fut to an iron pin; thence S. 69-00 E. 15 fut to an  
iron pin on the South side of the National Highway; thence  
S. 19-00 W. 200 fut to an iron pin; thence N. 74-15 W. 85 fut  
to an iron pin; thence N. 15-48 E. 200 fut to the beginning  
Corner.
