all that tract or lot of land in Township, Greenville County, State of South Carolina.

on the White Horse Road, about three miles from Greenville Courthouse known as tracts nos. 2 and 4 on the revised plat of the Yawn property, and having the following courses and distances according to said plat. Tract No. 4: Beginning at a stake in the center of the White Horse Road, corner of tract no. 3 and running thence with line of tract no. 3, N. 72-10 E. 603 feet to stake in line of Charles property; thence with Charles line N. 15-10 W. 290.5 feet to stake, corner tract 2; thence with line of tract no. 2 S. 64-05 W. 645.3 feet to stake in center of White Horse Road; thence with White Horse Road S. 24-30 E. 200 feet to the beginning. Tract No. 2: Beginning at a stake in the center of the White Horse Road at corner of tract no. 4 and running thence with line of tract no. 4, N. 64-05 E. 645.3 feet to a stake in line of Charles property; thence with Charles line N. 15-10 W. 323 feet to iron pipe in ditch; thence S. 56-42 W. with ditch 705.5 feet to stake in White Horse Road; thence with White Horse Road S. 24-30 E. 227.1 feet to beginning corner. This is a first mortgage on the above two tracts of land. Also that other tract of land in Lantt Township, County and State aforesaid, on the east side of White Horse Road, near Welcome School, having the following courses and distances according to plat made by R. C. Haltow, Engineer, November 26, 1921. Beginning at an iron pipe on the east side of the White Horse Road, corner of Mrs. C. Y. Looper, and running thence N. 63-10 E. 125 feet to iron pipe; thence N. 27-10 E. 53.5 feet to iron pipe; thence N. 68-30 E. 330 feet to pipe; thence N. 45-55 E. 345.5 feet to pipe; thence S. 15-10 E. 761.5 feet to pipe, corner of tract no. 2; thence S. 56-42 W. 721.5 feet to point in White Horse Road, thence, the road the line, in a northwesterly direction 721.2 feet to the beginning, known as tract no. 1 on plat above referred to, and containing 12.11 acres, more or less.
