Being just outside the corporate limits of the City of Greenville, on the northeast corner of Sumner Street and M^c Bee Boulevard, and being known and designated as Lot 17 of Block "B" and a strip 3 feet wide of the southern edge of Lot 18, Block "B", on plat of the property of Sumner Investment Company, recorded in Plat Book "A", pages 122-123, R. M. C. Office for Greenville County, said lot having the following Metes and bounds to wit: Beginning at a stake on the north side of Sumner Street at corner of lot 16 on said plat and running thence with line of lot 16, N. 51-26 W. 76 feet to stake corner of lot 18; thence with line of lots 16 and 18, N. 51-26 W. 8 feet to stake; thence S. 58-34 W. 149.66 feet to stake on the east side of M^c Bee Boulevard thence with the eastern side of M^c Bee Boulevard and the northern side of Sumner Street as the line 195 feet more or less to the beginning corner.
