in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to National Realty Management Co., Inc., in the full and just sum of Twenty-five Thousand (\$3,500.00) Dollars, to be paid both principal and interest being payable at the office of National Realty Management Co., Inc., 90 West Street, New York, N.Y., as follows: Two hundred Fifty (\$350.00) Dollars on November 15, 1936, \$200.00 on May 15, 1936, and a like amount on the 15th day of each November and May thereafter up to and including May 15, 1941, and the balance due on the same date, to-wit, May 15, 1941, with interest thereon from date.

at the rate of six per centum per annum, to be computed and paid annually

(included in the above principal) until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

National Realty Management Co., Inc., its successors and assigns:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, known and designated as lot number 6 of North Hills, according to plat of said property, made by Dalton and Neves, and recorded in the R. M. C. Office for Greenville County in Plat Book 6, at page 40, and having a frontage on Elizabeth Street of 150 feet, and on Garraux Street of 40 feet, and having the following metes and bounds, to-wit:

Beginning at an iron pin, the corner of the eastern side of Elizabeth Street and the northern side of Garraux Street, and running thence along Elizabeth Street, N. 13-12 E. 150 feet to an iron pin on a ten-foot alley; thence along said alley, S. 66-02 E. 62.5 feet; thence S. 32-05 E. 147.8 feet to a point on Garraux Street; thence along Garraux Street, N. 66-02 E. 40 feet to the point of beginning.
