TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Myrtle Howie
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, I, Myrtle Howie, the said Myrtle Howie *has satisfied*
in and by my certain note or obligation, bearing date the 11th day of August 1933
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly
incorporated under the laws of such State), in the sum of Three Thousand Dollars (\$3,000.00)
with interest thereon at the rate of eight per centum per annum, payable monthly from the 11th day of August A. D. 1933
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
I, the said Myrtle Howie, shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly on the 20th or before the end of the month of September
1933, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Five Dollars (\$5.00)
Three Dollars (\$3.00) Dollars, being the regular monthly installment payable on the
Five Dollars (\$5.00) Shares of Stock and Two Dollars (\$2.00) Dollars,
being the monthly interest on the advance of loan) until they have been paid twenty monthly payments, and shall for the next twenty months pay the sum of
Four Dollars and 60/100 (\$4.60) Dollars, (\$3.00) Dollars, being the regular monthly payment on said stock and
One Dollar and 60/100 (\$1.60) Dollars,
being the monthly interest on balance due); for the next twenty months the sum of Four Dollars and 20/100 (\$4.20) Dollars,
(\$3.00) Dollars, being the regular monthly payment on said stock and One Dollar and 20/100 (\$1.20) Dollars,
being the monthly interest on balance due); for the next twenty months pay the sum of Three Dollars and 80/100 (\$3.80)
Dollars, (\$3.00) Dollars, being the monthly installment on said shares of stock and
eighty cents (.80) Dollars, being the monthly interest on balance due); for the next twenty months pay the
sum of Three Dollars and 40/100 (\$3.40) Dollars, (\$3.00) Dollars, being the
monthly payment on said shares of stock and forty cents (.40) cents Dollars,
being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company
the said three shares of stock and the certificate thereon, the amount at such time paid shares by to be
credited as a payment upon the advance or loan made. Myrtle Howie, the said Myrtle Howie
and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against the said
Myrtle Howie in accordance with the Charter, By-Laws, Rules and Regulations, as in
and by the said note or obligation, and the condition thereunder written, reference being thereunto had, all more fully appear.

NOW, KNOW ALL MEN, That I, the said Myrtle Howie
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to
the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to the said Myrtle
Howard

in hand well and truly paid by the said The Carolina Loan and Trust Company, at the time of the signing and delivery of these Presents, (the receipt whereof is hereby acknowledged),
have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel
of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In the Township of Greenville, near The City of Greenville, known as lot No. 18,
of Block B of City View, according to a plat thereof recorded in plat book A, at
pages 460 and 461, said lot having a frontage of 50 feet on Y. M. C. A. Street with
a depth of 150 feet, to an alley; this is the same land conveyed to the said Myrtle
Howard by W. H. Ballard by deed of even date herewith.

For value received we hereby transfer and assign the within mort-
gage and the note it secures to J. W. Burnett without recourse.
