with interest thereon, from date, nor at the rate of 6 per cent. per annum to be computed and paid.

Semi-Annually and

28 Pat me Isarity, if any part in full interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, and note further providing for an attorney's fee of

6 per cent

besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said Elsie M. Griffith, Nov. 36, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell and release unto the said Pat me Isarity.

All that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, on the North side of Cathran Street, and being known and designated as Lot No. 20 on plat of property of Wade Cathran, made by Dalton & Nease, Engineers, in July, 1927, and recorded in office of R.M.C. for Greenville, County, in Plat Book 26, at Page 163, and having the following lines and bounds, to wit: Beginning at an iron pin on the North side of Cathran Street, at the S.E. corner of Lot No. 21, which pin is 235 feet from the North East corner of McDaniel Avenue and Cathran Street and running thence along line of Lot No. 21, N. 90° 35' E. 162.5 ft. to an iron pin at joint corner of Lots Nos. 21, 22, 23 and 20; thence along line of lot No. 23, S. 81° 15' E. 65 ft. to an iron pin at joint corner of Lots Nos. 23, 24, 19 and 20; thence along line of lot No. 19 S. 9° 35' W. 162.5 ft. to an iron pin on the North side of Cathran Street; thence along North side of Cathran Street N. 81° 15' W. 65 feet, to the beginning corner.
