All that piece parcel or tract of land situate, lying and being in the State and County aforesaid, on the head waters of South Tyger River, and in Highland Township, on the East side of the State Road, and has the following metes and bounds: Beginning at a stake in the State Road, thence N. 69 E. 5.00 chs to a stake in head of Tyger River, thence with said River as a line 30.67 chs to a stake in said River; thence S. 85 21. 5.10 chs to a stake in State Road; thence along said Road as a line 30.30 chs to the beginning corner, containing sixteen (16) acres, more or less.

Also all that other piece, parcel or tract of land adjoining the above described tract, having the following metes and bounds: Beginning at a stake in head Tyger River, thence N. 55 E. 33.50 chs across branch to a poplar, thence N. 21 21. 03 chs to a large s. o; thence N. 23 24. 8.50 chs to a stake; thence S. 43 54. 19.48 chs to a stake; thence N. 13 1/2 E. 18.59 chs to a pine; thence S. 70 1/2 E. to a stone; thence S. 85 21. 2.75 chs to stake in head of Tyger River, thence with said head of Tyger River as a line to the beginning corner, containing sixty-six (66) acres more or less.
