Lots nos. 17 & 18; Beginning at a point on the South side
of Spruce Street, joint corner of lots nos. 16 & 17, and run-
ning thence N. 53 W. 50 feet, along Spruce Street to corner
of lot no. 19; thence along the rear line of lots nos. 20 and
19, S. 32 W. 60 feet, joint corner with lots nos. 20 and 21
and 23; thence along the rear line of lots nos. 23 and 24,
