WHEREAS, *I*, the said *Allie H. Carson*

in and by *my* certain promissory note in writing, of even date with these presents *and* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of

*Twenty-three Hundred no 100* Dollars,
