the event that I _____ shall at any time fail to do so then the said mortgagee may cause the same to be insured in its name and
reimburse itself for the premium and expense of such insurance with interest under this mortgage.

And if I _____ shall make default in the payment of the said weekly interest as aforesaid, or shall fail or refuse to keep the
buildings on said premises insured as aforesaid, or shall make default in any of the aforesaid stipulations for the space of thirty days or shall cease to be a member of said Association

incumbrance, shall be added to and constitute a part of the debt hereby secured, and shall bear interest at same rate.
