Now, therefore, in consideration of the premises, and in further consideration of one dollar paid him in hand, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to wit:

In the 5th ward of the City of Greenville, containing 28/100 acres, more or less, and being bounded on the south - west side of Birnie Street, thence with O'Neal St. No. 60 1/2 W. 102 4 feet to corner of Birnie and Geur Streets; thence with Geur Street S. 71 70. 74 feet to iron pin on old town line; thence S. 19 1/2 E. 122 feet to iron pin 3 ft; thence N. 57 E. 152 feet to the beginning corner.

Also all that other certain piece, parcel or lot of land in said County and State, described as follows, more or less, adjoining above described lot, beginning at an iron pin on Birnie Street and running thence with street N. 60 1/2 W. 72 feet to iron pin 3 ft; thence N. 57 W. 152 feet to iron pin 3 ft; on old town line; thence S. 19 1/2 E. 66 feet to iron pin 3 ft; thence N. 57 E. 203 feet to the beginning corner.

Also all that other certain piece, parcel or lot of land in said County and State, adjoining first above described lot, beginning at stake No. 1 on Geur Street and running thence with said street S. 69 1/4 W. 65 feet to stake; Marine Bank corner; thence S. 20 1/4 E. 120 feet to a stake, corner of Lot No. 5; thence with line of Lot No. 5 N. 67 3/4 E. 65 feet to a stake; thence N. 20 1/4 W. 120 feet to the beginning corner.
