SEND GREETING:

WHEREAS, *J. J. S. Shae*, the said *J. J. S. Shae*,  
 in and by *J. J. S. Shae* certain *Prunary*, note... in writing, of  
 even date with these presents, *J. J. S. Shae*, well and truly indebted to  
*G. H. Center*,

in the full and just sum of *Fifteen Hundred and Two Dollars - 15.00.00*  
 Dollars, to be paid *Decem. year of date*.

*The Debtor hereby secures his debt  
with interest thereon, from the date of this  
Contract and the same is to be paid at  
the rate of eight per cent. per annum to be  
computed and paid monthly.*

*... until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of  
principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note... to become immediately due, at the option of the holder hereof,  
who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten per cent.*  
... besides all costs and expenses of collection, to be added to the amount due on the said note..., to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note..., reference being thereunto had, as will more fully appear.*

NOW, KNOW ALL MEN, That *J. J. S. Shae*, the said *J. J. S. Shae*,  
 in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *G. H. Center*,

*according to the terms of the said note... and also in consideration of the further sum of Three Dollars, to *J. J. S. Shae*, the said...*

*J. J. S. Shae* *doth* *acknowledges* *and* *agrees* *to* *pay* *the* *sum* *of* *Three* *Dollars*, *to* *J. J. S. Shae*, *the* *said...*  
*and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bar-*  
*gain, sell and release unto the said *J. J. S. Shae*, his heirs and assigns, forever, the*

*following described property;*

*All that certain piece, or lot of land, situate and  
lying in State and County aforesaid, Ossabaw Township, and  
lying on both sides of Jordan Road, having the following  
bounds and bounds, to wit: Beginning at a stone & O. M. stone  
corner and running thence S. 05 1/2 W. 17.50 cho. to stone;  
thence S. 80 E. 15.00 cho. to stone; thence N. 88 1/4 E. 25.75 cho. to  
a stone corner; thence N. 2 1/2 E. 10.90 cho. to a stone; thence  
N. 85 1/2 W. 27.50 cho. to the beginning corner and containing 43 1/2  
acres, more or less and being the same tract of land conveyed to  
me by H. J. Babb, due to same recorded in H. M. C. office for  
Greenville County in Vol. 91 at page 85.*
