SEND GREETING:

WHEREAS, *I*, the said *J. P. Wilson*

in the full and just sum of *Five hundred and no. 100*
Dollars, to be paid *one year after date*

with interest thereon, from *date* at the rate of *eight* per cent. per annum to be
computed and paid *semi-annually 30th day*

until paid in full, interest not paid when due to bear interest at the same rate as principal; and if any portion of
principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note... to become immediately due, at the option of the holder hereof,
who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten per cent of amount*
due besides all costs and expenses of collection, to be
added to the amount due on the said note... to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note... reference being
thereunto had, as will more fully appear.

gain, sell and release unto the said *Lucia Jones*

having courses and distances, to wit: Beginning at
the corner of a ten foot alley and Stace Street, and
running thence N 3/4 E. 150 feet to a stake; thence
S. 86 1/4 E. 60 feet to a stake, corner of lot no. 6; thence
S. 3/4 W. with line of lot no. 6, 150 feet to stake on
Stace street; thence N. 86 1/4 W. with said street 60
