

AGREEMENT FOR EXTENSION OF LOAN NO. 200749

WHEREAS, There now remains unpaid on a certain note executed and delivered by H. G. Boyd

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said R. H. Boyd, Jessie R. Boyd, Pearl B. Bryson and Ivy B. Young

hereby agree to pay the principal sum remaining due as aforesaid as follows: The Principal sum of Fifty-Two Hundred (\$5,200.00) Dollars, being payable in annual instalments as follows, viz: Beginning on the fifteenth day of January, 1933, and on the same day in each succeeding year thereafter, the sum of \$200.00, and the balance of said principal sum being payable on the fifteenth day of January, 1937.

with interest thereon from January 15, 1922, to \_\_\_\_\_, at the rate of six per cent. per annum, payable \_\_\_\_\_ annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments of \$100.00 or any multiple thereof of the principal sum of said note on any interest maturity date, and the amount so paid shall be credited

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
