

AGREEMENT FOR EXTENSION OF LOAN NO. 211382

WHEREAS, There now remains unpaid on a certain note executed and delivered by

Elizabeth N. Dickson and W. M. Dickson, Jr..

to

The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated June 1, 1927, recorded in said County on June 1, 1927,

in Volume 171 of Mortgages on Page 47, the sum of One Thousand Six Hundred Eighty (\$1,680.00) Dollars, with interest from June 1, 1932, and,

WHEREAS, Title to the mortgaged premises is now vested in Elizabeth N. Dickson and W. M. Dickson, Jr.

subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said Elizabeth N. Dickson and W. M. Dickson, Jr.

hereby agree to pay the principal sum remaining due as aforesaid as follows:

\$42.00 on December 1, 1932; \$42.00 on June 1, 1933; \$42.00 on December 1, 1933; \$42.00 on June 1, 1934; \$42.00 on December 1, 1934; \$42.00 on June 1, 1935; \$42.00 on December 1, 1935; \$42.00 on June 1, 1936; \$42.00 on December 1, 1936; and \$1,302.00 on June 1, 1937.

with interest thereon from June 1, 1932, to June 1, 1937, at the rate of six (6%) per cent. per annum, payable semi-annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of this note in sums of \$100.00 or multiples thereof on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
