

AGREEMENT FOR EXTENSION OF LOAN NO. 250426

WHEREAS, There now remains unpaid on a certain note executed and delivered by Christ Church, Greenville,

to

The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated November 1, 1928, recorded in said County on 2nd November 1928, 19 in Volume 205 of Mortgages on Page 309, the sum of Twenty-three Thousand Eight Hundred Dollars, with interest from November 1, 1933, and,

WHEREAS, Title to the mortgaged premises is now vested in Christ Church, Greenville

subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said Christ Church, Greenville,

hereby agree to pay the principal sum remaining due as aforesaid as follows: The sum of \$300.00 on February 1, 1934, and quarterly payments of \$300.00 on the first day of each and every May, August, November and February thereafter during the life of this agreement, and the balance of the principal on the first day of November, 1938.

with interest thereon from November 1, 1933 to November 1, 1938 at the rate of six per cent. per annum, payable quarterly on the first day of February, May, August and November of each year,

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments of \$100.00 or any multiple thereof on the principal of this loan at any interest payment date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
