

AGREEMENT FOR EXTENSION OF LOAN NO. 271696-3

WHEREAS, There now remains unpaid on a certain note executed and delivered by

George P. Roberson

to

The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated September 18th, 1929, recorded in said County on September 19th, 1929, in Volume 171 of mortgages on Page 64, the sum of Five Thousand (\$5,000.00) Dollars, with interest from September 18th, 1934, and,

WHEREAS, Title to the mortgaged premises is now vested in

George P. Roberson

subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said George P. Roberson

hereby agree to pay the principal sum remaining due as aforesaid as follows: One Hundred Twenty-Five (\$125.00) Dollars on March 18th, 1935, and quarterly payments of One Hundred Twenty-Five (\$125) Dollars on the 18th day of each and every June, September, December and March thereafter during the life of this agreement, and the balance of the principal on the 18th day of September, 1939,

with interest thereon from September 18th, 1934, to September 18th, 1939, at the rate of five and one-half per cent. per annum, quarterly on the 18th day of December, March, June + September of each year, and with payable annually, and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of said note in sums of \$100.00 or multiples thereof, on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
