WHEREAS, I, H. J. Southern,

in and by my certain promissory note in writing, of even date with these presents, well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of eleven hundred no/100 Dollars,

in Greenville Township, known and designated as Lot No. 3 of Block Z as shown on plat of Riverside Land Company recorded in P. M. C. office for Greenville County in Plat Book A, page 323, said lot having a frontage of 50 feet on Highlawn Avenue, with a depth of 125 feet.
