TO ALL WHOM THESE PRESENTS MAY CONCERN:

*I, Millie F. Lee* *in full* *1936* *Assoc*

SEND GREETING:

WHEREAS, *I*, the said *Millie F. Lee*

in and by *my* certain promissory note in writing, of even date with these presents, well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and

just sum of *Twenty six hundred no. 100* Dollars,

to be paid on or before the date when the *50th* Series of the Instalment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *I* fail to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hand of an attorney for collection, or if said debt or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That *I* the said *Millie F. Lee*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN

ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of *Three Dollars* to *me*

the said *Millie F. Lee*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN

BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

*Near the city of Greenville, known as part of lots nos. 14 and 15 of the subdivision of Eastover, plat of same recorded in Plat Book F, page 42, and also a triangular strip purchased by me from Ellison G. Glenn, adjoining said Eastover lots, having the following meter bearings: Beginning at an iron pin on the north side of Glenn Street 62.2 feet from Beechwood Avenue, thence with line of N. C. Smith 143 feet to a point on line of lot 15 and 16 of Eastover Subdivision; thence with line of lot no. 15 N. 18-05 E. 10 feet to an iron pin; thence with line of lot no. 16 approximately two feet; thence with line of Ellison Glenn 55 feet to an iron pin; thence with line of F. D. Lott 150 feet to an iron pin on Glenn Street; thence with Glenn Street 60 feet to the beginning.*
