I, W. L. Burton,

SEND GREETING:

WHEREAS, I, the said W. L. Burton,

in and by my certain promissory note in writing, of even date with these presents am well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of Eight Hundred Fifty & no/100 Dollars,

to be paid on or before the date when the 55' Series of the Instalment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of 8 1/2% per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I fail to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hand of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear.

BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

Greenville Township, about two miles from Greenville Court House, near the Laurens Road, known as Lot No. 38 on plat of Eastover, recorded in the R. M. C. office for Greenville County in Plat Book "F" at page 42, and having the following courses and distances according to said plat:

Beginning at an iron pin at the Southwest corner of Ackley Street and Beechwood Avenue and running thence with Ackley Street S. 64-30 W. 150 feet to iron pin, corner of Lot No. 37; thence with line of said lot N. 25-30 W. 60 feet to iron pin, corner of Lot No. 39; thence with line of said Lot N. 64-30 E. 153.2 feet to iron pin on Beechwood Avenue and thence with said Avenue S. 22-26 E. 60.1 feet to the beginning corner, being the same land deeded to me by E.
