his Heirs and Assigns, forever, all and singular that certain piece, parcel, lot or tract of land situate, lying and being in **Greenville City, Greenville** County, State aforesaid,

being lots Nos. 19 and 20 of a subdivision of **Hewell Lands**, represented by a plat in Plat Book A, page 163.

Beginning **an** Dunbar Street, at Atkinson's corner, thence running with Dunbar Street, N. 76 W. 100 feet; thence S. 18 W. 215 feet to Davis lot; thence S. 76 E. 131 feet, more or less; thence N. 10 E. 215 feet to beginning corner.
