Hall by deed dated January 19, 1933, deed not yet recorded. Also all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near Judron Mills, known as Lots Nos. 40 and 41 on Plat of lands of Pride + Patton Land Company made by R.
