Beginning at an iron pin on the North side of Warner Street 129.2 feet from the Northwest intersection of Warner Street and McPherson Street, and running thence N. 9-35 E. 165 feet to an iron pin on the boundary of the property of the Donaldson Estate; thence N. 81-15 W. 65 feet to an iron pin, joint corner of Lots Nos. 32 and 33; thence S. 9-35 W. 165 feet to an iron pin on Warner Street; thence S. 81-15 E. 65 feet to the beginning corner.
