all that tract or lot of land in *Butler* Township, Greenville County, State of South Carolina.

Containing  $45\frac{1}{4}$  acres, more or less;  
Beginning at a stake on the road N. W. Thence N.  $76\frac{1}{2}$  W. 18.58 to a stake on corner. Thence N.  $13\frac{1}{2}$  E. 19.10 (19.00) to a stake N.W. corner. Thence N.  $76$  E. 19.00 to a stake N.W. corner. Thence S.  $37$  E. 14.60 to a stake X.W. corner. Thence N.  $87\frac{1}{2}$  W. 13.90 to a stake on the road. Thence along road S.  $1$  E. 16.37 to the beginning corner, adjoining lands of *St. H. Hall* and others and known as the *John Hudson Place* and being part of the land owned by *V.
