in the full and just sum of Two hundred six and 70/100 Dollars  
to be paid at or before the day of January (\$10.00) to be paid between  
the first and fifth day of each and every month  
according to the rate of interest mentioned and demanded  
and in full date of

at the rate of 8 per cent. per annum, to be computed and paid until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of 10 per cent  
besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

Euorle Fork Baptist Church;

A certain tract of land or lot of land containing one and a half acres of land, the same more or less, joining church lot, situated in Greenville County and State aforesaid between the Euorle Fork and Sparling roads, Augusta Roads, beginning at a stone on Augusta Road 3x4, thence N. 24 E. 5.00 to a stone on Sparling road 3x4, thence up said road 4.17 to a stone 3x4; thence S. 11 1/4 W. 307 to a pine on said Augusta road 3x4, thence down said road S. 54 E. 3.13 to the beginning stone, bounded by church lot and lots A. & Smith.

Also, a certain lot or tract of land situated lying and being in said State and County, Chick Springs township on the Public Road known as the Greenville and Spartanburg Road and also on the public road leading from Taylors Station to Reidsville, bounded by lands of the said Fork Church and the said A. & Smith, containing one and one twentieth acres more or less, bounded as follows, viz: Beginning in a stone on the said Greenville and Spartanburg Road S. 57 1/2 W. 35.52 chs. to a black oak on said road leading from Taylors to Reidsville, thence S. 07 1/4 E. .88 chs to a stone, thence N. 42 1/2 E. 6.19 chs. to a stone in a spring; thence N. 25 1/4 W. .88 chs to a stone on said Greenville and Spartanburg Road, thence along said road S. 80 1/2 W. 2.25 chs. to the beginning corner.
