All that piece, parcel or tract of land situate, lying and being in the State and County aforesaid on the head of South Tyger River, in Highland Township, and has the following metes and bounds, to-wit:

Beginning at a stake in the State Road, thence N. 69° E. 5.00 chs. to a stake in head of Tyger River, thence with said River as a line 30.67 chs. to a stake in State Road, thence S. 85° W. 5.10 chs. to a stake in State Road, thence along State Road as a line 30.20 chs. to the beginning corner, containing sixteen (16) acres, more or less.

Also: All that other piece, parcel or tract of land adjoining the above described tract and having the following metes and bounds to wit:
