at the rate of 6 per cent. per annum, to be computed and paid

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of 6 per cent.

All that tract or parcel of land situated in the County of Greenville, State of South Carolina and described as follows: Situated just outside the incorporate limits of the City of Greenville and being all of lot #1 and the major portion of lot #2 of Woodside Circle as shown on plat recorded in the R. M.C. Office for Greenville County in Plat Book "E" at page 219 and having the following metes and bounds, to-wit:

Beginning on the Rutherford Road in center of Brick Wall between Drug Store and Piedmont Grocery, about 40 feet from the stone line and running thence S. 66° 03' E. 147.5 feet to corner; thence in a line parallel with Rutherford Road 10 feet, more or less, to the stone line, thence with stone line N. 78° 51' W. 156 feet to Rutherford Road, thence with Rutherford Road 40 feet, more or less, to the beginning. Being part of the property conveyed to me by L. H. Dickey by Deed dated Dec 11, 1930 and recorded in the R. M.C. Office for Greenville County in Deed Book 71 at page 155.
