besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof. If the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said A. H. Schader,
his heirs and assigns forever: All that certain piece, parcel or tract of land
situate, lie and being in the State of South Carolina, County of Greenville
and in Park Mountain Township, on Franklin Road about three miles from
the City of Greenville on Franklin Road about three miles from the City of
Greenville, near the old Sans Souci Country Club, and being described as
follows: Beginning at an iron pin on Franklin Road 300 feet west of
the corner of the Park of the Traction Company, and running thence N. 23-35
E. 6-39 feet 6 inches to the creek or branch at Tindal's line, thence N. 62-50
W. 16-26 feet to an iron pin on Langston's creek, thence with Langstone
creek and down same 716 feet to center of the bridge over the creek on
Franklin Road, thence with Franklin Road S. 70-32 E. 1103 feet to a land
in the road, thence still with said Franklin Road S. 65-25 E. 610 feet to an iron
pin at the beginning corner, containing 25 acres, more or less, and being
the same tract of land conveyed to Mabel W. Ligon by J. E. LaGrone, by deed
dated April 25, 1922 and recorded in the R. M. C. Office for Greenville County in Vol 62 page 589.

adjoining the above described tract, and having the following metes and

with Tindal's line 69.2 feet to Mabel W. Ligon's corner, thence with Mabel
