All that piece, parcel or lot of land evilvate in Greenville Township, County of Greenville, State of South Carolina, on Green Avenue, in the Catty of Greenville, fronting Sixty (60) feet on said Green Avenue, and raining back, a depth of One hundred (100) feet, more or less, being the lot where By the Farrow formerly resided, and composed, of two lots as follows: (1) the lot conveyed to B. W. Farrow by Anderson Jones by deed dated June 18, 1896 recorded in the office of the R. L. C. for Greenville County, S.C. in Deed Book EER (3-E), at rage 403, except that part conveyed by B. W. Farrow to John Arner by deed recorded prisaid office in Deed Book III, at page 783; and (2) the lot conveyed to BW W. Farrow by W. D. Workman by deed dated July, 1921, recorded in the office of the R. M. C. for Greenville County, S. C., in Deed Book 92, at page 360.

To Have and to nold, all and singular the said premises unto the Mortgagee, its successors and assigns, forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the bortgagor and all persons whomseever lawfully claiming the same or any part thereof.

- (a) If this mortgage and the note secured hereby are insured under the provision of the Netional Housing Act and so long as they continue to be so insured, one-twelfth (1/12) of One-half of one per centum ($\frac{1}{2}$) of the oringinal principal amount of the said note for the purpose of putting the bortgagee in funds with which to discharge the Mortgagee's obligation to the Federal Housing Administrator for mortgage insurance premiums pursuant to the provisions of witle II of the National Housing Act and Rules and Regulations thereunder. The Mortgageeshall, on the termination of its obligation to pay mortgage insurance premiums, credit to the account of the Mortgagor all payments
