All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, on the southeast side of Butler Avenue in Ward One of the City of Greenville and being described as follows:

Beginning at a stake on Butler Avenue 150 feet from the corner of Hampton Avenue and Butler Avenue and running thence with Butler Avenue S. 18 2/3. 50 feet to a stake, the corner of what was formerly C. A. Merricks' line; thence S. 64 1/4 E. 156 feet to F. A. Walter's corner; thence with F. A. Walter's line N. 18 E. 50 feet to Richardson's line; thence N. 64 1/4 W. 156 feet to the beginning corner, containing 7,800 square feet, more or less, and being the same lot conveyed to Emma E. Howell December 11, 1915 by Athena J. Richardson by deed recorded in the R. M. C. Office for Greenville County in Vol 38, page 326, and inherited by myself and my sister Irene H. Bruner, daughters and the only heirs, at law of said Emma E. Howell deceased, the undivided one half interest of Irene H. Bruner having been conveyed to me by deed dated July 31, 1930 and not yet recorded.
