All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, near the Augusta Road School site, on Highland Drive, and being known as Lat. no 57 of the L. B. Martin sub-division as shown on a plat of record in the R. M. C. Office for Greenville County in Plat Book F, page 102, and having according to said plat the following meter and bounds, to-wit:
