WHEREAS, *I*, the said *Flora T. Hayes*,

Dollars, *to be paid* *one year from date with right of anticipation*

 with interest thereon, from *date* *July 17, 1936* *at the rate of* *7* *per cent. per annum to be*
 computed and paid *sense annually* *July 17, 1936*
 until paid in full; *Interest not paid when due to bear interest at the same rate as principal; and if any portion of*
principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note *to become immediately due, at the option of the holder hereof, who may*
sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *10%*.

 according to the terms of the said note, and also in consideration of the further sum of Three Dollars *(\$3.00)*, the said *Flora T. Hayes*,

 at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell
 and release unto the said *Byrdie T. Smith and Furman L. Sprith*, these

heirs and assigns forever:

All that piece, parcel or lot of land in Greenville
 Township, Greenville County, State of South Carolina, in Ward
 5 of the City of Greenville, on the East side of Mallard Street,
 and being known and designated as portion of Lot no 4
 of the J. A. Snyder land, plat of same being recorded in
 Plat Book "E" at page 142, R. M.C. Office for Greenville County
 and being more particularly described as follows:

Beginning at iron pin on the East
 side of Mallard Street at corner of Hewell's property,
 and running thence with that line S. 75 E. 117 feet
 to rear line of lot now or formerly owned by
 B. C. Wright; thence with Wright's line N. 15.30 E.
 68 feet to an iron pin in line of Lot no 2; thence
 with the line of Lot no 2. N. 75 W. 110 feet to an iron
 pin on East side of Mallard Street; thence with
 Mallard Street S. 21.15 W. 68.4 feet more or less to the
 beginning corner.
