Springs Township, Greenville County, State of South Car-
olina, on the Furman Hall Road, and being a portion
of Tract No. 4, of the property of J. C. Hall, as shown on
plat thereof made by A. G. Dalton, Dec-1916, and having the
following metes and bounds, to-wit:

Beginning at an iron pin on the East side of Furman Hall
road, 109 feet from the intersection of the Furman Hall
Road, with the Chick Springs Road, corner lot of B. L. Par-
