and release unto the said Ben Lewis

All that certain piece, parcel or lot of land situate, lying and
being in the State of South Carolina, County of Greenville and City of
Greenville and being known and designated as Lot # 3 according to
plat of property D.R. Bain, Trustee made by W.M. Rast, Engineer in
August of 1928 which plat is of record in Plat Book "H" at page one
hundred thirty-five (135) in the office of the Register of Deeds
Conveyance for Greenville County, reference to which is express-
ly made as a part of this description. Said lot of land has a front-
age of fifty feet on the North side of East Croft Street and has a depth
of one hundred five and five tenths feet.

This is the same lot of land heretofore conveyed to Eliza M. Redmon by deed of Henry J. Martin dated June 27, 1930, and
recorded in deed book 152 at page 253 in the said R.M.B.
office.

It is understood that the lien of this mortgage is junior
to the lien of the mortgage given by Eliza M. Redmon on
April 22, 1932 to Mechanics Building and Loan Association
for the sum of (\$2500) Twenty-Five Hundred Dollars, which mort-
gage is recorded in Mortgage Book 234 at page 8; and is
junior to the mortgage given by Eliza M. Redmon on July 3,
1932 to H.J. Martin for the sum of \$530.00 Five Hundred Thirty
Dollars, which mortgage is recorded in Mortgage book 229
at Page 25.
