in the full and just sum of Two Hundred Dollars (\$200.00), to be paid in 14 months from the date hereof, and the receipt of \$200.00 to be paid in one year from the date 2/12/36.

with interest thereon, from date at the rate of 7 per cent. per annum to be computed and paid quarterly until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of 1/2 percent.

b. All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Hick Spring Township, and being a portion of a 6.6 acre tract, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of the Old Rutherford Road, at a point 100 feet south from the intersection of Old Rutherford Road with Pine Street, and running thence N. 21-20 W. 339 feet more or less to an iron pin on the east side of Cherry Street, at a point 100 feet from the intersection of said Cherry Street with Pine Street; thence S. 7-15 W. 100 feet to an iron pin on Cherry Street, thence S. 21-20 E. 339 feet more or less to an iron pin on Rutherford road; thence following the line of said road approximately N. 14-30 E. 100 feet to the beginning corner, said is the same conveyed to me by the mortgagee herein, of which date.
