Release Deed.

Union Trust Company of Maryland, Baltimore, Maryland, and Edgar J. Hecht, of the City, County and State of New York, as Trustees in the deed of trust hereinafter set forth, in consideration of the debt thereby secured having been fully paid and satisfied, do hereby release the lien of a certain deed of trust made by Lewis Barber, unmarried, to Union Trust Company of Maryland and Edgar J. Hecht, as trustees, dated the 15th day of January, 1933, and registered in the office of the R. M. C. of Greenville County, South Carolina, on the 10th day of February, 1933 in Book 243, Page 247, the property thereby conveyed being described as follows:

Situate near the City of Greenville, in the County of Greenville, State of South Carolina, on the West side of Brookdale Avenue, in the subdivision known as Fair Heights, and being known and designated as Lot No. 25, of Block 4, of said subdivision, and having, according to plat made by Dalton & Neves, Engineers, April, 1923, the following metes and bounds, to wit:

Beginning at an iron pipe on the West side of Brookdale Avenue, 263.7 feet South of the Laurens Road, and running thence with Brookdale Avenue S 31-20 W. 50 feet to an iron pin; thence N. 58-40 W. 150 feet to an iron pin; thence N. 31-20 E. 50 feet to an iron pin; thence S. 58-40 E. 150 feet to the point of beginning on Brookdale Avenue.

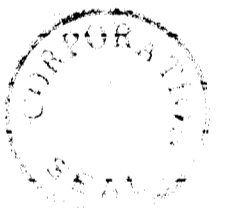
