Release Deed.

Whereas, Union Trust Company of Maryland, Baltimore, Maryland, one of the Trustees in the deed of trust hereinafter set forth, has resigned as such trustee and refuses and declines to further act in such capacity, its resignation being recorded in the R. M. C. Office for Greenville County on July 8, 1936, in Deed Book 1188, at Page 225

Now, therefore, Edgar J. Hecht as Trustee (being the surviving Trustee, in, and by virtue of, the authority vested in him under provision 14 of the mortgage or deed of trust, hereinafter referred to, in consideration of the debt thereby secured having been fully paid and satisfied, does hereby release the lien of a certain deed of trust made by Lewis Barber to Union Trust Company of Maryland, Baltimore, Md., and Edgar J. Hecht, as Trustee, on the 15th day of December, 1931, and filed for record in the R. M. C. Office for Greenville County, South Carolina, in Mortgage Book 183, page 289, the property thereby conveyed being described as follows:-

All that certain piece, parcel or lot of land, situate, lying and being on the north side of the Laurens Road, being known and designated as Lot #13 of Block "C" of Carolina Court, as shown on plat recorded in the R. M. C. Office for Greenville County in Plat Book J, at Page 96, and having according to said plat the following metes and bounds to-wit: Beginning at a point on the north side of Laurens Road, which point is 203 feet in a westerly direction from the northwest corner of Montevista Avenue and Laurens Road, and running thence along Laurens Road, N. 55-45 N. 67.8 feet, to corner of Lots # 2 and 3; thence N. 28-02 E, along the joint line of said lots 198.3 feet to a point on line of Lots # 3 and 4; thence S 27-0 N. 198.4 feet to the point of beginning.

The Registrar of Greenville County is hereby authorized and directed to satisfy the said deed of trust of record by endorsing such satisfaction upon the records of said deed of trust in book 183 at Page 289 of Mortgages in the office of the R. M. C. for Greenville County, South Carolina, in witness whereof the said Edgar J. Hecht has hereunto set his hand and seal this the 23rd day of September A.D. 1936.
