TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Wade Pittman

WHEREAS, I, the said Wade Pittman SEND GREETING:

in and by my certain promissory note in writing, of even date with these presents, N. A. Pittman well and truly indebted to in the full and just sum of Two Hundred (\$200.00)

Dollars, to be paid Fifty (\$50.00) dollars one year from date, and Fifty (\$50.00) dollars on the 21st day of September of each and every year thereafter, until the entire debt is paid in full with interest with interest thereon from date at the rate of 5 per cent. per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said N. A. Pittman

All that piece, parcel or lot of land in Saluda Township, Greenville County, State of South Carolina, lying on the south side of the Ridge Road leading West from Tigerville by way of Cross Plains to the Buncombe Road, about two and one-half (2 1/2) miles from Tigerville and adjoining lands of Robert Pittman on the west, Henry Pittman and John Pol on the south, and Dewey Hudson formerly Albert Pittman on the east, and bordering on the aforesaid Ridge Road on the north and containing sixteen (16) acres, more or less.
