with interest thereon from October 2, 1936 at the rate of six per cent. per annum, to be computed and paid at maturity and paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note..... to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note..... after maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note..... or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that lot of land in Greenville County, State of South Carolina, near the corporate limits of the City of Greenville, on the south side of Prentiss Avenue, known as Lot #5 of Block #1 of the O. P. Mills property, according to plat recorded in the R. M. B. Office for Greenville County in Plat Book "B" at page 176, and having the following metes and bounds:

N. Beginning on the south side of Prentiss Avenue 126.5 feet from the corner of Mission Street (formerly Church Street); thence along the south side of Prentiss Avenue N. 45-27 E. 63 feet to an iron pin. Thence S. 44-33 E. 180 feet to an iron pin; thence S. 45-27 N. 63 feet to an iron pin, thence N. 44-33 N. 180 feet to the beginning corner. This being the same lot of land conveyed to W. H. Griffin by Lauretta L. Rossett, by deed dated September 8, 1934, and recorded in the R. M. B. Office for Greenville County in Book of Deeds "172" at Page 346, and later conveyed by W. H. Griffin to P. M. Baine and recorded in the R. M. B. Office for Greenville County in Volume 187 at Page 347.
