heirs, executors, administrators and assigns and every person whomsoever lawfully claiming or to claim the same or any part thereof.

And the said mortgagor agrees to insure the house and buildings on said lot in a sum not less than Twenty Five Hundred
(#2500.00) Dollars, in a company or companies satisfactory to the mortgagee and keep the same insured from loss or dam-
